

# In 2008 Quinn Emanuel Remained a Great Investment:

WON jury verdict of \$100 million and permanent injunction for Mattel in copyright and business tort case against MGA, the maker of "Bratz" dolls.

WON complete dismissal with prejudice for two electronics distributors of securities fraud charges in first post-Stoneridge 10b-5 case.

WON Ninth Circuit affirmance for eBay of summary judgment in trademark infringement and unfair competition case.

WON settlement after trial for Solutia on eve of exit from its four-year bankruptcy case, requiring lenders to perform on \$2 billion financing commitment.

WON Final Determination ruling for Epson in ITC which found Epson's 31 patent claims all valid and infringed by 25 respondents.

WON denial of TRO and preliminary injunction for Alltel against Verizon's false advertising claims.

WON \$2.1 billion settlement for hedge funds from Citibank and Enron relating to Enron credit-linked notes.

WON complete dismissal for Belgian holding company of claim for \$400 million in damages in civil RICO case.

WON summary judgment of non-infringement and obviousness for Bally Technologies against IGT and Shuffle Master in patent litigation relating to casino table game monitoring.

WON unanimous decision in pro bono case from California Supreme Court reversing death sentence of inmate placed on death row in 1982 on grounds that government violated defendant's Brady rights.

WON jury verdict and judgment of \$32.5 million, including attorneys' fees for LA-based developers in breach of contract litigation related to hotel/condo project at Mammoth ski resort.

WON affirmance by California Court of Appeal for Academy of Motion Pictures Arts and Sciences of judgment dismissing claims brought by co-producer of "Crash" relating to eligibility for Academy Awards.

WON summary judgment dismissing copyright infringement claims of over \$100 million brought against director and screenwriters of "The Last Samurai."

WON dismissal for Harley Davidson of putative class action by employees asserting negligence and breach of warranty claims.

WON dismissal for pro bono client of indictment in the Southern District of New York alleging participation in illegal gun trafficking ring.

WON jury trial on breach of contract and \$225 million offsetting damages in class action for Sprint Wireless, resulting in no damages for the class.

WON Federal Circuit reversal of summary judgment granted against Bancorp in patent litigation relating to management of stable value life insurance plans.

WON \$5 million jury verdict for Hollywood producer Robert Cort in breach of contract and fraud action arising from agreement to finance film development projects.

WON acquittal during post-trial proceedings on two lead counts for individual convicted of engaging in scheme to conceal and conspiracy to defraud government.

WON summary judgment for Roche in patent infringement case brought by Stanford University regarding HIV patents for viral load and therapy decisions.

WON ruling in Ninth Circuit for major Japanese publisher affirming largest award of attorneys' fees in history of California's anti-SLAPP law.

WON summary judgment for IAC/InterActiveCorp, LendingTree and ServiceMagic defeating over \$100 million in patent infringement claims regarding website operations.

WON reversal of TRO threatening Upper Deck's entire \$100+ million 2008 baseball card business.

WON more than \$77 million and obtained four consent judgments for Northrop Grumman on patent covering optical fiber amplifiers.

WON Federal Circuit affirmance of summary judgment for Motorola resulting in dismissal of patent infringement claims against 26 cell phone manufacturers regarding text-messaging technology.

WON favorable settlement for Nokia on eve of trial in world's largest patent infringement litigation against Qualcomm.

WON favorable settlement for Motorola on eve of re-trial in trade secret case.

WON unanimous arbitration award of \$10 million for XE Capital after defendant failed to pay commissions due in joint venture.

WON summary judgment for Washington Redskins dismissing claim for cancellation of Redskins' trademark registrations.

WON preliminary injunction for Finance Express in trademark and domain name infringement and false advertising case.

WON arbitration for various venture capital firms sued for fraudulent inducement by founder of leading Internet company.

WON \$12 million settlement for individual inventor on claim that Corning's method of making LCD glass infringed inventor's patent rights.

WON \$65 million settlement against Facebook.

WON Ninth Circuit affirmance of order dismissing with prejudice shareholder derivative action against Public Storage and its officers and directors.

WON summary judgment for Activision dismissing all claims by rock group "The Romantics" relating to music appearing in popular GUITAR HERO™ video game.
