Just recently, it collected \$5.3 million for a carbon fiber bicycle defect which caused paralysis to the victim; \$2.75 million for a mild traumatic brain injury in the Bronx; \$5 million for a lead paint poisoning case; \$3 million for a child who was blinded in one eye as a result of playing with a defective toy; a verdict of \$2.8 million in favor of a worker injured on a job site; \$1 million for a sixty-four year old nursing home patient who was hospitalized for thermal burns after being left unattended, another \$1 million for a sexually assaulted female student at a public school; settlements of \$750,000, \$640,000, \$470,000, and \$400,000 in four separate construction accidents; as well as recoveries for hundreds of clients in the \$4.85 Billion Settlement against Merck over their controversial painkiller Vioxx, which was one of the largest Civil Settlements in History.

One particular point of pride for the firm is its fearless work and recent gains in the mass torts arena, especially with regard to pharmaceutical liability.
