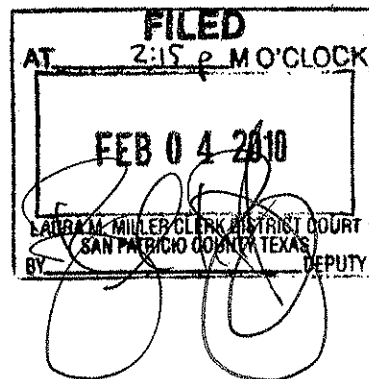

FINAL JUDGMENT

On this the 4 day of FEBRUARY, 2010, came on to be heard Plaintiffs' Motion for Entry of Final Judgment and the Court having considered the following matter submitted by the parties and the arguments of counsel is of the opinion that the said Motion should be GRANTED.

It is, THEREFORE, ORDERED, ADJUDGED and DECREED that Plaintiffs' Motion for entry of Final Judgment is GRANTED.

1. Therefore, it is ORDERED, ADJUDGED and DECREED that Defendant Gulf Island Fabrication, Inc. is liable in the total amount of \$3,503,425.10 and each Plaintiff is entitled to recover as judgment against Defendant Gulf Island Fabrication, Inc. in the following amounts:

- (a) Lucinda Flores - \$1,575,280.06
- (b) Adrian G. Flores, Jr. - \$157,528.01
- (c) Alejandro Flores - \$450,080.02
- (d) Jose Flores - \$157,528.01
- (e) Francisca Flores - \$157,528.01
- (f) Venice Flores Metzler - 157,528.01
- (g) Marian Flores - \$315,059.51
- (h) The Estate of Adrian G. Flores, Sr., Deceased -- \$667,917.48

2. Therefore, it is ORDERED, ADJUDGED and DECREED that Defendant Gulf Island, LLC is liable in the total amount of \$5,004,893.00 and each Plaintiff is entitled to recover as judgment against Defendant Gulf Island, LLC in the following amounts:

- (a) Lucinda Flores - \$2,250,400.09
- (b) Adrian G. Flores, Jr. - \$225,040.01
- (c) Alejandro Flores - \$450,080.02
- (d) Jose Flores - \$225,040.01
- (e) Francisca Flores - \$225,040.01
- (f) Venice Flores Metzler - \$225,040.01
- (g) Marian Flores - \$450,085.02
- (h) The Estate of Adrian G. Flores, Sr., Deceased - \$954,167.83

3. **The total judgment for all Plaintiffs is: \$10,009,786.00 [\$4,859,786.00 (past damages with pre-judgment interest) + \$5,150,000.00 (future damages) = \$10,009,786.00]. Gulf Island Fabrication, Inc. is liable for 35% of \$10,009,786.00 which is \$3,503,425.10.**

[\$10,009,786.00 x 35% = \$3,503,425.10] and Gulf Island, LLC is liable for 50% of \$10,009,786.00 which is \$5,004,893.00.

4. It is therefore ORDERED, ADJUDGED and DECREED that Plaintiffs have and recover the total amount of \$8,508318.10 from Defendants Gulf Island Fabrication, Inc. and Gulf Island, LLC (in the proportions stated above in paragraph 3).

5. Post-judgment interest shall accrue at the maximum legal rate on all sums awarded to Plaintiffs and against Defendants from the date of this Final Judgment. All costs of court are likewise taxed as to Defendants Gulf Island Fabrication, Inc. and Gulf Island, L.L.C.

6. This Judgment disposes of all issues and parties and is final and applicable. All relief not expressly granted by this Judgment is denied.
